General Notes:

1. A 10 year warranty applies to new mechanical WTIs fitted by Accurate Controls Ltd only, otherwise a 12 month warranty applies.
2. A 5 year warranty applies to new PFM's fitted by Accurate Controls Ltd only, otherwise a 12 month warranty applies.
3. Warranty covers material defect, manufacturing defect or installation defect.
4. The above price allows for two engineers, to visit the site and that all the installation and commissioning work can be undertaken with minimal delays and interruptions and that any site induction is not protracted.
5. Access to the top of the transformer is assumed to be by securely lashed and footed ladder.
6. The above price includes the preparation of all necessary Method Statements and Risk Assessments and for attending any pre installation safety meetings.
7. Accurate can only guarantee the mA output from instrument terminals, it is the responsibility of the customer for connection to the SCADA system and any remote indicator.
8. The above price does not include any modifications to the existing site drawings to reflect any changes to the kiosk and temperature controllers, please request a quote if required.
9. SUPERVISION: Accurate Controls will provide Engineers with a minimum of National Grid "Person" qualification and current BESC AME qualifications. If it is the site operators' rules that these are not sufficient qualifications then it is the responsibility of the Site Operator to provide adequate supervision i.e. "Personal Supervision" or similar for the duration of the works. Failure to provide suitable supervision to our Engineers will result in the works being either cancelled or postponed if our engineers are not permitted to start work due to a lack of supervision. Accurate Controls reserves the right to invoice up and to and including the total amount due for the works that were planned plus all reasonable expenses incurred as a result of this.

Note:

Re-scheduling and cancellation

The scale of charges for the re-scheduling or cancellation of previously booked site work is as follows:
